Tendering will be in accordance with the **National Competitive Tendering Method** (NCT) procedures as specified in the Public Procurement Act, 2003 (ACT 663) as Amended and the stated Guidelines of the Public Procurement Authority of the Republic of Ghana.
- 3. Tenderers shall quote for all quantities in the lot. Tenders not offering all quantities in the lot shall be declared non-responsive.
- 4. Interested eligible suppliers may obtain a complete set of Tender documents at the address below from **Monday to Friday** between the hours of **09:00 a.m. to 4:00 p.m.** The documents will be available from **May 20, 2021 to June 04, 2021** for inspection and purchase.
