Tendering will be conducted in accordance with the National Competitive Tendering Method (NCT) procedures as specified in the Public Procurement Act, 2003 (Act 663) as amended and the guidelines of the Public Procurement Authority of the Republic of Ghana.

 - vi. Valid Public Procurement Authority (PPA) Suppliers Registration Certificate;
 - vii. 2% Tender Security in the right amount from a reputable Bank in Ghana;
 - viii. Form A or Form 3 and Form 4.
